<u>"禁足令"未明</u> 快用 eRO 提櫃無懼疫情走勢

各位物流界朋友及一路通服務用户,大家好!

最近的新型冠狀病毒捲土重來,在香港各區相繼爆發,頗多個案源頭未 明,醫學及公共衛生界權威亦認為,減少外出及保持社交距離是當前要 務,在未有藥物、疫苗前仍須繼續,社會更有不少訴求提議短期內應實 施禁足令。按當前疫情,企業紛紛開展短中線安排以應對看似持續的疫 情,包括暫時關閉服務中心、縮短服務時間或落實遙距營商等等,當中 包括物流界的朋友,如船公司、貨代、代理。

入口提重,若以傳統方式到船公司服務櫃台換單,將產生大量不必要的 社交機會,亦受制於船公司或貨代服務櫃台的時間改動;而一路通的電 子提櫃單 (eRO) 服務,為物流業界提供電子提重的新常態,讓船公司、 貨主、貨代、運輸公司、貨櫃碼頭及外圍堆場以數碼化方式處理入口文 件、提櫃及回吉;讓用戶不受船公司縮減櫃台服務時間的影響,並可足 不出户,在任何時間全天候進行入口提櫃工作,減少營運上因疫情所帶 來的衝擊。

<u>'Stay-At-Home' Order Remains Uncertain;</u> Use eRO for Import Release to Combat Covid-19 Resurgence

Dear eRO users and fellows in the logistics industry,

A new wave of Covid-19 has surfaced again, with hundreds uncovered in various districts of the city. Among the newly found cases, a considerable number come from untraceable sources. Given the current situation, experts in medicine and public health areas also advise citizens to stay home as much as possible and practise social distancing until medicines and vaccines are available. Some citizens even advocate that stay-at-home order should be implemented in no time. Amid the ravaging pandemic, businesses in different industries continue to prep up and implement short and medium term measures – including temporary closure of business centres, shortening business hours or implementation of distance business – to cope with challenges in this seemingly prolonged crisis. Liners, forwarders and agents in the logistics industry are among those who consider these measures.

Import release, if handled through traditional paper-based way at liners' service counters, will create numerous undesirable social contacts and be unfavourably subject to changes of liners' or forwarders' service hours. As a major industry transformation, OnePort's electronic Release Order (eRO) service offers relief to the industry by enabling a new normal of electronic release. Liners, consignees, forwarders, container terminals and outside depots are able to utilize this digitised method in handling import instructions, laden pickup and empty return. eRO users are unaffected by reduced business hours at service counters of shipping lines. With accessibility to internet, eRO users are able to work at home and proceed with import release process anywhere, anytime. This new working mode greatly reduces operational impact caused by the pandemic.

We earnestly invite members of the port community to use eRO service which is now provided by more than 95% of liners. <u>Please begin by visiting</u> <u>http://ero.oneport.com</u> and follow instructions outlined in the attached "eRO <u>Quick Start". Consignees or forwarders can easily complete their part simply by</u> forwarding an eRO to your trucking company upon receipt from your liner.

事前準備:

- 完成登記手續
 - 進行以下快速使用前,必先於 <u>http://reg.oneport.com/</u> 完成登記手續,並 經由電郵取得系統登入資料。
- 以下只適用於司機
 - 司機須預先於手機下載應用程式港口通電子提櫃單 (HKiPort eRO) , 並要求你的 運輸公司預先提供你的登入資料。

貨主	 ● 於我的貨物下按匯入貨物,選擇船公司(或貨代),並輸入提單編號及提單上 其中一個貨櫃編號。再按提交。再按匯入便可將自己的櫃貨資料匯入戶口 內。
	 第二步:向船公司請求電子提櫃單 在我的貨物下,剔選想換的提單/貨櫃,按請求電子提櫃單。 按系統要求填妥資料後,以一次性密碼簽署擔保函,以便提交請求並等候船 公司發放電子提櫃單(eRO)。
	第三步:轉送予運輸公司
	 ● 收到船公司發放的 eRO 後,在 我的提櫃單下,剔選相關的 eRO。按轉送。 ● 輸入你運輸的一路通公司代號,按轉送。再選擇負責繳付港口保安費的一方,再按確認便可。

可機	 第一步:運輸公司於系統編配車輛及司機取櫃 ● 在我的提櫃單下,剔選該貨櫃並按指派。選擇車牌及司機,按指派貨櫃車便可。被指派的司機亦會收到該 eRO 的二維碼 (QR 碼)。
	 第二步:司機於碼頭出示 QR 碼取櫃 司機須向碼頭工作人員出示 QR 碼,在系統指示的倉期內入場提櫃。 如何尋找 QR 碼:登入 HKiPort eRO 手機程式後,便能看到所有屬於司機的 eRO。按一按你想查閱的 eRO,進入其詳細資料,然後在最下方找到 QR 碼,再按一下放大 QR 碼。

Electronic Release Order (eRO) Service - Quick Start

Preparation:

- Complete Registration Procedure
 - Before starting the following steps, you are required to sign up for eRO service at <u>http://reg.oneport.com/</u>. You will then receive your login credentials, by email, for your access to eRO system.
- Only Applicable to Truck Drivers
 - Truck drivers are required to download mobile app HKiPort eRO and obtain your login information from your trucking company in advance.

Quick Start

- Log in at <u>https://ero.oneport.com/</u> and start using eRO.

Forwarders & Consignees	 Step 1: Import Shipment Click Import Shipment under My Shipment tab. Select shipping line or forwarder. Enter bill number and any container number which is on the bill. Click Submit and then Import for preparing LOI in order to import your shipment information into your account.
	 Step 2: Submit Request for eRO to Liner Under My Shipment tab, check the bill or containers which you would like to process. Click Request eRO button. Fill the details as requested on the system interface. Sign the electronic letter of indemnity (eLOI) by a one-time Online Authorization Code (OAC). Then, submit the request for an eRO.
	 Step 3: Forward to Trucking Company Upon receipt of an eRO issued by your liner, select the relevant bill/ containers under eRO tab. Click Forward button. Enter the Company ID of your trucking company. Click Forward button. Select the party which will pay for the Port Security Charge. Click Confirm button.
Trucking Companies &Truck Drivers	 *** Ensure your customer has already forwarded the eRO to you (trucking company). Step 1: Trucking Company to Assign Tractor and Driver Under My eRO tab, select the appropriate container and click Assign. Select the plate number & the driver. Click Assign to tractor and the truck driver will receive the corresponding QR code at the same time.
	 Step 2: Driver to Pick up a Laden by Presenting QR Code at Terminal Driver should present the QR code to terminals and pick up the laden container within free storage period as indicated on system. How to find the QR code: After login to mobile app HKiPort eRO, you will see a list of eROs. Press the one you want to enquire in order to check its details. You will find the QR code at the bottom. Press to enlarge the QR code.
	 Step 3: Driver to Return an Empty to Location as Indicated on System Driver should return the empty to location within free detention period as indicated on system. <u>Return to Terminal</u>: same as Step 2 <u>Return to Outside Depot</u>: For the ease of depot operators, please bring along the relevant eRO Reference Copy.
