Dear Valued Customer,

In respond to the announcement of Hong Kong Container Terminal Operators Association (HKCTOA) regarding full implementation of Electronic Release Order (eRO) started from 10 February 2020 (please refer to https://example.com/hKCTOA's announcement), Ocean Network Express (East Asia) Limited will provide the issue of paper Delivery Order (D/O) at Import Service Counter for below customers ONLY:

- customers who are in application of eRO service
- customers' shipment is under CFS cargo

Effective from 2 November 2020 (Monday), the Delivery Order (D/O) cut-off time will be revised as follows:

AM CUT-OFF (11:00)

- Order received at Counter **before** AM cut-off time will be ready by 12:30.

PM CUT-OFF (12:30)

- Order received at Counter **before** PM cut-off time will be ready on the same day;
- Order received at Counter after PM cut-off time will be ready by 12:30 on next working day.
